Public Hearing on Budget – No public was present. Public Hearing Adjourned at 7:01 pm.

Additions to Agenda – No additions to the agenda. Removal of Comments from the Volunteer Association and Master Plan Discussion.

Approval of June 2021 Minutes – June Walker made the motion to approve the minutes. B. Burr seconded the motion. No discussion. Motion passed.

Correspondence – Election results received in mail today. Position 3 will be filled with Jason Prenevost and position 1 will be filled with Bob Burr.

Unfinished Business – None

Treasurers Report – Chief reviewed the financials statements. He reminded the board the district is moving to a cash basis accounting. The year is projected to finish on budget.

J. Walker made the motion to pay the bills. J Meyers seconded motion; motion passed.

New Business -

The air conditioning unit which services the sleeping quarters, community room and kitchen has failed. Bids have been obtained for the 20-year-old unit repair and replacement. The unit has a 15-year projected lifespan. A new unit is approximately \$13-15k.

The Board via verbal consensus approved updating the LB-31 Operating Contingency to provide for the new air conditioning unit purchase to \$24,551.

June Walker moved to accept the Resolution Adopting the Budget for the 2021-22 fiscal year, making appropriations, imposing and categorizing the tax as presented. Bob Burr seconded the motion; motion passed.

June Walker moved to accept the tax rate as presented in the resolution. J. Meyers the motion; motion passed.

M. Ballenger moved to adopt the Resolution transferring \$25,000 into the Equipment Reserve Fund from the General Fund for future expenditures. June Walker seconded. The motion passed unanimously.

Training program has been updated to allow firefighters more time with equipment while training.

A recent water rescue prompted a discussion on procuring a used boat for call response. Discussions are ensuing with LCSO with the goal of obtaining a boat in the next 18 months.

Chief noted maintenance around the walking path off Wetleau is needed and encouraged partnership with the city and homeowners to create defensible space and fire awareness. Firefighters will be taking a fire assessment tool class to work with homeowners to make their property safer.

In the approved 21-22 budget, wages were updated to reflect a COLA increase and alignment with new wage laws. If implemented July 1 the Board would need to approve the increases tonight.

John Meyers moved to approve a 3% increase for Chief Dragt. – June Walker seconded. Motion passed.

John Meyers moved to approve a 3% increase for firefighters. June Walker seconded. Motion passed.

Chief provided a call briefing including an increase in backyard burning calls. Calls for May: 11 Medical, 1 Fire Calls, 8 MVA and 9 others. Total of 30 calls.
