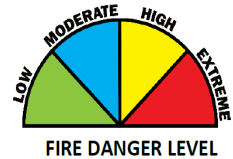

| <b>Motor vehicles</b> including motorcycles and all-terrain vehicles, are only allowed on roads free from flammable vegetation, except for the cultivation and harvest of agricultural crops. Each vehicle traveling on forestland, except on state highways, county roads, and driveways must have one shovel and one gallon of water or one 2.5 lb. or larger fire extinguisher. | <b>Mowing/Cutting</b> of dried and cured grasses is restricted. | <b>Non-Industrial Gasoline Saw Use</b> when allowed, each saw being used is required to have one shovel and fire extinguisher of at least 8 ounce capacity. | <b>Campfires, cooking fires and warming fires</b> are acceptable when used in an area cleared of flammable vegetation. A charged garden hose or one 2.5 lb. or larger fire extinguisher must be immediately available.
